CONDITIONS OF ENTRY - TEAMS

- Tables Butterfly Blue
- Nets Butterfly Nets
- Ball Stag 3 Star White Ball

EQUIPMENT

- Only TTNZ registered members are eligible to represent NZ Associations in this event and they may represent only the Association with which they are registered (except as per the condition below).
- Associations which have at least two (2) players may request additional players from the drafting pool to form a team in any championship and play under the name of the applying association. Associations which have only one player available for any championship may apply to have that player placed in the drafting pool. TTNZ will allocate drafting pool players to teams and their decision will be final.
- In any contest only one (1) draft player may be used.
- Eligibility for age group events is determined by age as at 31/12/2009 for Under 18/15 events, or 31/12/2010 for 040, 050 events. Proof of age may be required.
- Eligibility for team events shall be determined from the TTNZ Rating list as the closing date.

ELIGIBILITY

- Entries must be accompanied by correct fees. TTNZ reserves the right to reject entries not accompanied by the correct fees.
- TTNZ reserves the right to refuse any entry and to vary restrictions at its discretion.
- All teams comprise of 3 players and a team shall not be represented by more than five player throughout the championship.
- Any one player may enter a maximum of one (1) Open team's event and one (1) age group team's event.
- Associations can enter unlimited teams in any category however a maximum of 2 teams per association will be allowed in the A grade of any such category.
- Players enter at their own risk and no responsibility will be accepted for any injury received during the tournament.
- Team fees \$45 per team, \$15 per draft player.
- Grades: Open, U18, U15, 040, 050 and all three (3) player teams.

ENTRIES

- Each contest will comprise of three players per team and the order of play shall be: Singles Av2, Bv1, Cv3, Av1, BC v 23 Doubles.
- The names of the players declared for each team will be used to grade and seed teams. Please ensure all players have confirmed their availability before naming them and that the named players will compete.
- Teams will be ranked into grades. It is preferred to have 8 teams in a grade and played as a round robin.
- Team matches at all national team events in 2010 (North and South Island Team Championships, NZ Junior and NZ Senior Open Championships) must be played to completion. The only exception is playoff matches that can finish at a result.
- Before the start of a team match, participating teams must list the players for each of A, B, C or X, Y, Z. Only after the 2nd match has been played do teams need to decide their doubles pairing.
- TTNZ Handbook regulations will be applied. If an item is not covered by the TTNZ regulations, then the ITTF regulations will apply as appropriate.

DRAWS & MATCHES

- The New Zealand Sports Drug Agency reserves the right to conduct random drug testing.
- No glueing shall be permitted inside the stadium other than within areas designated for the purpose.
- The Tournament Manager is authorised to make any such decisions on any issues relating to the tournament that are not covered by the TTNZ Handbook or entry form conditions.
- The Tournament Referee reserves the right to apply and enforce the Laws of Table Tennis as adopted by TTNZ. Their interpretation of these laws and regulations is final.
- Approved racket coverings must be used as per the ITTF list current at the date of the tournament.
